Fees are payable on the day of the burial.**

Payment of fees assumes acceptance of Cemetery By-Laws.

Town Bylaws
Cemeteries

1. Every lot shall be held subject to the provisions of these By-Laws and rules and regulations presently in force or as amended hereafter. Lot purchaser will acknowledge receipt of a copy of the cemetery By-Laws of West Stockbridge.
2. When a lot is purchased, only the right of human burial is secured, not the land itself.
3. The Commission will set fees for burial sites, registration fee and site work.
4. The Commission prior to installation must approve the size, kind and placement of stones or monuments. A three-foot foundation is required under the headstone and footstone placements.
5. Corner markers are required for all burial lots at owner's expense.
6. No plantings shall be made on any lot without permission of the Commission. The Commission reserves the right to remove any previous, present or future plantings, which are detrimental, dangerous or inconvenient, in the judgment of the Commission, at the Owner's Expense.
7. Tree plantings within Town Cemeteries are strictly prohibited. Existing trees whose roots interfere with cemetery plots and/or disturbing stone placements will be removed, at owner's expense.
8. The Commission will arrange to remove flowers, wreaths or other decoration left on the lot when they become unsightly and bill the owner.
9. Winter wreath decorations are permitted from November 11 (Veteran's Day) until April 15. After that date the Town will remove them.
10. Motorcycles, motorbikes, motor scooters, snowmobiles, dogs and horses are prohibited unless on official business, speed limit, 15 miles per hour.
Cemetery Hours: 8:00 am to sunset.
11. Lots or parts thereof may not be resold, but may be repurchased by the Town. All sales must have Commission approval.
12. The Commission is in charge of all matters pertaining to the management of the cemetery grounds and the Commission may make additional rulings as deemed expedient in contingencies.
13. No work of any kind may be done on the grounds without approval of the Chairman or the Commission in the absence of the Chairman.
